WHEREAS, the subdividers of Memorial Glen Subdivision, First Memorial Glen Corporation, Second Memorial Glen Corporation and Third Memorial Glen Corporation, filed instruments in the County Clerk's Office, Harris County, Texas on July 23, 1961 (Vol. 4434, page 243), October 2, 1961 (Vol. 2508, page 523) and December 14, 1961 (Vol. 4577, page 420), which instruments subjected each lot to an annual maintenance charge payable on January first of each year, in advance, to said subdividers or their assigns, and

WHEREAS, by instrument dated February 19, 1965 filed in the County Clerk's Office, Harris County, Texas on March 10, 1965 (Vol. 5848, page 239), said subdividers assigned to Memorial Glen Property Owners, Inc. all of their duties, obligations and authority in respect of the collection and disbursement of the annual maintenance charges mentioned in paragraph "(b)" of each of the three instruments adopting and establishing such charges, and

applicable to lots 123, 124 and 125 under circumstances therein specified, and

WHEREAS all of the owners have consented in writing, the signature of each such lot owner being duly acknowledged, to the amendment aforesaid;

PLEASE TAKE FURTHER NOTICE that all lot owners have added their signatures (duly acknowledged) to the amendment to restrictions heretofore signed and acknowledged by the subdividers and filed in the County Clerk's Office, Harris County, Vol. 5848, pages 241, et seq.
